Q Level Calculations

1 yr experience, not certified with CA/CPA
- Level 2**
2 yrs experience, not certified with CA/CPA
- Level 3**
3 yrs experience
OR
In process of CA/CPA certification
- Level 4**
6 yrs experience
OR
CA/CPA certified
- Level 5**
8 yrs experience
OR
2 yrs experience + CA/CPA certified
- Q Partner**
10+ yrs experience
OR
5 yrs experience + CA/CPA certified

Examples

Supplementation

Elizabeth is currently employed at a firm, she loves her job and is in the process of getting her CPA accreditation.
